1. Welcome the following WV Counties that joined the family of the Circuit Express Providers:

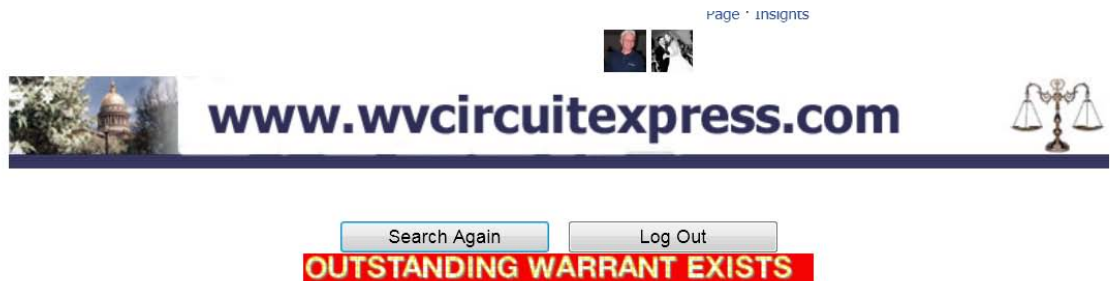

 - a. Upgraded the infrastructure to from DSL to Frontier Metro Ethernet which increased our bandwidth
 - b. Modified the search engine to speed up "ALL County" Searches
5. Created the ability to begin a search at a particular case number and then see all cases sequentially following that case. From the search page enter:
